# **Open Letter to Netcare Users April**, 2012



#### RE: Professional responsibility to protect privacy, security and confidentiality of patient health information

Netcare is a valuable tool in managing patient information. It provides convenient access to important patient data and results, at the click of a button.

As with any patient records, with access to information comes great responsibility.

As a follow up on breaches of patient privacy related to Alberta Netcare Portal, we, as members of the provincial committees who provide advice to electronic health record initiatives, feel it is important to remind Netcare users of the accountability we all have to protect patient privacy. Only through diligent use of confidential information will we maintain the trust of our patients and Albertans in general. Only through trust will this valued clinical information tool, now used by some 34,000 clinical and other authorized staff province-wide, continue to contribute to the highest quality patient care.

Building this kind of trust is taken very seriously. The inappropriate use of Netcare is a breach of our most important professional responsibility - the responsibility we have to our patients. It can result in sanctions, fines of up to \$100,000, and potential litigation. The Office of the Information and Privacy Commissioner (OIPC) has levied such fines and professional organizations have imposed other sanctions.

There are measures in place to protect our patients. Every user access in Netcare is tracked and routine audits are conducted monthly. Additional audits and OIPC investigations can be triggered by a patient requesting a log of who has accessed his/her record and/or raising a concern about a probable breach. As well, any Netcare user can flag a potential breach.

The Provincial Data Stewardship Committee is a multidisciplinary committee appointed by the Minister to oversee stewardship of the Alberta Electronic Health Record (EHR). The Committee manages, maintains and interprets rules for acceptable uses and disclosures of health information in the EHR.

# **Helpful Principles to Guide Your Use of Netcare**

**Netcare is a valuable tool and its proper use for patient care is encouraged.** Inappropriate use is prohibited. Examples of inappropriate Netcare use include:

- accessing the record of any individual with whom you do **not** have a care relationship, which can extend to:
  - your family and your relatives
  - famous, VIP or other patients
  - friends, acquaintances, colleagues, and colleagues' friends and acquaintances
- accessing your own health information
- accessing Netcare on behalf of a friend, acquaintance, colleague or a colleague's friend or acquaintance
- accessing masked information without the patient's consent or a strong clinical need

Netcare should be accessed with your own user name, password, and/or fob (credentials). Examples of inappropriate access could include:

- sharing these credentials with others or allowing others to access Netcare with your credentials
- using others' credentials
- leaving Netcare open on the screen so that others can view patient records

Netcare should be used to access the least amount of information required to make a care decision.

accessing more information than you require to perform your particular duty is inappropriate.

Approval processes need to be followed to access Netcare for non-care purposes such as research, quality assurance, etc. (for information, contact: <a href="mailto:HIAhelpdesk@gov.ab.ca">HIAhelpdesk@gov.ab.ca</a>).
