


FREQUENTLY ASKED QUESTIONS Community Information Integration Limited Production Roll Out

Alberta Health is increasing the number of community data sources that provide information to Alberta's electronic health record (Alberta Netcare) through the community information integration (CII) initiative.

It is estimated that 70 to 80% of health services are delivered in community clinic settings. Until now, there have been no mechanisms in place to upload this information into Alberta Netcare, and no ability for Alberta Health to use this information for health systems planning or quality improvement efforts. The CII initiative offers a solution. CII:



- Collects health data from primary care and community clinics in Alberta
- Presents the data in Alberta Netcare through clinically relevant reports
- Makes this data available for secondary use, such as quality improvement

Healthquest (Microquest) is the first electronic medical record (EMR) system that CII has linked to Alberta Netcare. Med Access, Wolf and PS Suite (TELUS) will follow in March 2018.

The first phase of the CII initiative is a limited production rollout (LPR), with a small sub-set of clinics that host these EMRs.



What is the CII clinic selection process?

Alberta Health, approved EMR vendors, the Alberta Medical Association (AMA), the College of Physicians and Surgeons of Alberta (CPSA) and the Primary Care Network (PCN) Evolution team are collaborating to identify suitable clinics for the LPR.

- First priority is given to clinics that are nominated by the partners listed above
- Second priority is given to clinics that nominate themselves
- Third priority is given to eligible clinics that are approached to participate from the potential LPR clinic list developed by the Vendor and the eHealth Support Services team



What is the CII clinic participation confirmation process?

The LPR confirmation process is based on eligibility, willingness and readiness characteristics defined in *Table A*, below. When all selection criteria are met, LPR participation is confirmed, otherwise clinics will be placed on the general production roll out (GPR) list.

Why do all Custodians in the clinic need to be willing to participate in the LPR?

All Custodians in the clinic need to be willing to participate in CII because the entire clinic's EMR data will go up in one nightly automated feed. There is no ability to isolate individual Custodian EMR data. If a new Custodian joins the clinic and does not want to participate in CII, the clinic would need to opt out of the LPR.

If a locum physician joins the CII clinic and does not want to participate in CII, there is no impact on the LPR. The locum physician is not considered a clinic Custodian, and is not the primary care provider for patients of that clinic. It will be up to the clinic's Custodian(s) to determine if they will continue to participate in the LPR.



Why do all CII clinic Custodians need to be on the same EMR?

To initiate and execute the LPR as efficiently as possible, the project scope outlines one automated, nightly clinic data submission from CII conformed EMRs. Therefore, clinics using multiple EMRs are not eligible to participate.



What is an LPR participation agreement and why do CII clinics need one?

An LPR participation agreement is established between participating CII clinics and Alberta Health to ensure LPR processes, procedures, and findings remain confidential. These processes and procedures are and will continue to be tested and validated to ensure the success of the general production roll out. The agreement also covers the clinic's acceptance to use the latest version of their EMR vendor's software. Further refinements will be made to both the EMR extraction process and the data integration process as health information is moved into Alberta Netcare and the results of the LPR are evaluated.

Do clinics need to revise their EMR PIA to participate in the CII project?

Alberta Health has prepared a Privacy Impact Assessment (PIA) that covers changes made to clinic EMR systems to accommodate disclosure of health information to CII. A synopsis of the Alberta Health PIA is provided to custodians during the sign up process. Custodians are asked to sign an endorsement letter for the Alberta Health PIA which explains that the custodian has been made aware of the changes to his/her EMR in support of the data extraction process. The endorsement letter indicates to the Office of Information and Privacy Commissioner (OIPC) that the physician/custodian's EMR, and the PIA covering it, are amended and that the Alberta Health PIA reflects these changes and the security measures taken to protect health information as a result of the changes.

The clinic is required to ensure all other privacy and security documentation as listed in *Table A*, above, are up to date. The CII implementation team works with clinics to confirm documentation. For further information, please contact the eHealth Support Services (eHSS) Team.

Why do CII clinics need to be willing to participate in LPR status meetings?

Clinic participation by the site liaison, who is appointed by the Custodian, in the LPR status meetings is the most efficient way to keep everyone on the same page and to resolve issues immediately. The site liaison will be responsible for updating the physicians. This is also an opportunity for clinics to share ideas and provide feedback on aspects of the LPR that could be changed or adapted to increase general production roll out success.

If a community clinic wants to participate, what is involved?

To participate, your clinic needs to be using Alberta Netcare and have an EMR privacy impact assessment (PIA) and provincial Organizational Readiness Assessment (pORA) that reflects the clinic's current IT environment. Signing up is simple. The time commitment is minimal – approximately three hours total over several weeks, and the site liaison, appointed by the custodian, can be any staff member in the clinic.
