How to Read a Patient's Immunization History



The **Immunization History** record contains patient immunization events, including the date of the event, the vaccine/antigen, and service location. Immunizations administered by Alberta Health Services across the province, along with other publicly funded vaccines, such as Influenza vaccinations given at pharmacies, are captured in the patient immunization record.

The link(s) are click-able and will populate the AEFI details. If there is no Adverse event, a message will indicate that "No Serious Adverse Event are available".

Adverse Events Following Immunization (AEFI) table contains high clinical data on adverse event following Immunization. Details on the adverse event, the date reported, the AEFI description of the event, AEFI#, whether or not the patient was hospitalized, Emergency Department (ED) visit, including the Regional Recommendations and the AEFI Detail.

Note: There are three coloured coded legend, gray for "Flu", green for "Adult" and blue for "Pediatric"

How to Read a Patient's Immunization History

1	[®] Select to expand an immunization event, allowing you to view the code, antigen, and
	count of the selected immunization. Collapse the event by selecting $ar{\square}$.
2	Indicates a demographic mismatch has occurred (date of birth or gender), and is under investigation.
3	Click Vaccination Code to sort results alphabetically, in ascending or descending order.
4	Click <i>Immunization Date</i> to sort immunizations by date, either chronologically or in reverse chronological order.
5	If the date of immunization event was estimated by a health care provider from an authentic immunization record, Yes will display. An immunization with an estimated date is considered to be a valid dose. The estimated date standard was adopted in November of 2011.
6	The age of the patient at the time of immunization displays in months and years for children (under 18 years), and in years only for adults.
7	Not Effective will display if the vaccine is not considered to be a valid dose
8	Yes will display if the patient has experienced a non-serious adverse reaction to the vaccine
9	Lists the location of the immunization event
10	If the date of the immunization event was estimated and confirmed by a healthcare provider, Yes will display.
1	Select to expand Serious Adverse event (AEFI), the "Report Date", the description of Events, details and supplementary information relating to the Adverse Events, to collapse the details, selecting .
	The "Report Date " of the serious adverse events
13	The description of the AEFI Event
14	The AEFI number is the unique number for each of the adverse event to immunization event reported by a delivery organization
15	The "Required Hospitalization" identifies if the Adverse Event patient was hospitalized as a result of the Adverse Event
16	The Emergency Room identifies if Adverse Event patient visited and was seen in an emergency department because of the Adverse Event.
	The "Regional Recommendations Comments" identifies input and recommendations from the Medical Officer of Health (MOH) or their designate of a Regional Health Authority or the First Nations & Inuit Health Branch regarding the Adverse Events.
18	The "AEFI Detail" identifies the adverse condition or symptom thought to be associated with the vaccines administered on the Immunization Date to the Adverse event patient.
