# **Protecting Patient Information: Alberta Netcare Masking**

Albertans have the option of requesting that their health information in Alberta Netcare be "masked." This means an individual's health information will not be automatically visible when their record is accessed, except for demographic information such as first and last name, date of birth, gender and personal health number.

#### **Custodian Responsibilities**

Participating custodians who have a current care relationship with the requesting individual are required to discuss with them:

- The risks and benefits of masking
- How the patient's health information will be accessed for treatment and care purposes
- That unmasking may occur without consent in specific situations

#### How to Begin the Masking Process

To initiate a masking request, the health care provider must complete the <u>Application for Masking form</u>. This document includes:

- Guidelines for submitting a request
- The formal procedure for applying or refusing a mask
- Required content for the patient discussion

# Be ready for what's next—go mobile

Starting September 1st, RSA SecurID soft tokens will be the default option for community users—supporting more secure, convenient and streamlined two-factor authentication for Alberta Netcare and related systems.

**Tip**: RSA tokens automatically deactivate after 180 days of inactivity. To keep your token active, log in regularly.

# Training & Learning Preparing the Next Generation of Netcare Users: Student Training

eHealth Student Education Services provides support to post-secondary institutions that introduces ANP and other Netcare related applications to future health care providers.

Providing students with early exposure and hands-on training helps prepare them to confidently integrate digital health tools into their future clinical practice.



#### Instructor-Led Training

Training sessions are tailored to the specific student role and typically run for 1.5 hours. The first half covers an overview of ANP along with key privacy and security concepts. The second half offers hands-on practice using the ANP Training Environment. Sessions are offered in-person or online via webinar.
